
# Deconstructing Wikileaks: Laura Sjoberg's Allegations and the Implications for Journalism

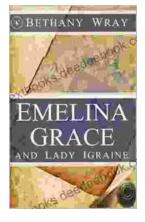
